

# Background Screening Solutions for Healthcare

The healthcare sector in the Asia Pacific region is undergoing rapid change. ## Why screen? It helps reduce vulnerability and risk.

People are often at their most vulnerable in a healthcare setting, be it a hospital, doctor's office, nursing home or other facility.

Background checks can protect patients and other vulnerable populations served by the healthcare industry, while supporting the ethics and integrity of businesses and the broader industry by helping employers:

- Ensure medical workers have the appropriate professional credentials.
- Validate critical information including education, employment experience and professional licensure.
- Identify a risky criminal history or professional sanctions that could jeopardise patients, colleagues or the organisation.
- Foster increased trust between patients and providers.
- Mitigate the potential for fraud and corruption.

## Who should be screened? Everybody.

Think about it: nearly every worker in the healthcare industry either has access to patients, their financial information or the drugs and devices used to support patient health. Knowing this, every healthcare employer should consider screening all workers with a risk-appropriate background check that's based on the level of access they have to patients, products or sensitive information.

#### This includes:

- Hospital and medical facility owners, board members, C-level executives
- All medical staff including physicians, surgeons, nurses, nurse practitioners, nurse assistants
- Pharmaceutical company board members, C-level executives
- · Directors, managers, salespeople

## Background checks help protect the vulnerable

Singapore: "A former Institute of Mental Health (IMH) nurse tasked to care for patients - including those who were severely mentally ill and suicidal abused his position and committed sexual offences against them instead."

The man was later sentenced to more than four years in jail and 10 strokes of the cane. A background check can help prevent healthcare organisations from hiring this man in the future when he's out of jail.
