  - You will have to get this form *notarised* we will send you the instructions on how to do this correctly once the check has been initiated
  - Once the check has been initiated, you will have to send this form by tracked post to our data supplier in the Czech Republic we will let you know the address to which you should send the form once the check has been initiated
- A signed consent form
  - You must sign, date, and tick the consent box in the 'Release of Information' part of the final section of this application form

When you have completed all the required paperwork, send it to the organisation that requested the check in line with their instructions.
