"Request for extract from the criminal records registry for purposes in another country"

General information

This form is for requesting an extract from the criminal records in accordance with section 9, second paragraph of the Criminal Records Act (1998:620) for purposes in another country.

The extract is always issued in five languages; Swedish, English, German, French and Spanish. Possible convictions are not translated and will appear only in Swedish.

The normal processing time is about two weeks, but if the form is incomplete or unclear, it may take longer.

Fields marked with * are compulsory if you are a citizen of the United Kingdom (UK) or an EU country other than Sweden.

Multilingual standard form/ translation aid

The form shall not be circulated as an autonomous between Member States. These forms may only be used within the EU. The cost of the multilingual standard form is 225 SEK.
