- Federal Drug Administration (FDA) lists names of investigators who have, at one time, been disqualified or restricted, or made assurances in their use of investigational products for FDA trials.
- State-specific OIG lists (where applicable).

Healthcare-Specific Searches (restricted):

- National Practitioners Data Bank (NPDB) provides information on medical malpractice payments, adverse licensure, clinical privilege and professional society membership actions.
- Healthcare Integrity and Protection Data Bank (HIPDB) provides information that combats fraud and abuse in health insurance and healthcare delivery.
